ORDER:

In the Government Order 1st read above, Guidelines have been issued for Construction Continuation Certificate (CCC) and Completion Certificate (CC) to all categories of buildings except Industrial buildings and residential buildings upto 3 dwelling units in Directorate of Town and Country Planning areas.

2. In the letter 3rd read above, The Commissioner of Town and Country Planning has stated that she received representation from various associations and also submitted the following common points of representation and remarks on the same.

SI.No.	Representation	Remarks
1.	To obtain Construction Continuance Certificate (CCC) for plinth level would delay construction and hence to remove it.	provides 15 days to issue Construction Continuation

2. Payment of fee of Rs.3/- per sq.ft. for issuing Construction Continuation Certificate & Completion Certificate is high and requested for waiver.

Reduction of both the rates of fee to be paid by the applicant and the fee to be paid to the empanelled professional may be considered. Rates may be Rs.1.00 per sq.ft. may be fixed as to be paid by the applicant and the rate payable to the empanelled professional may be – Rs.0.25 per sq.ft. for plinth level inspection and Rs.0.75 per sq.ft. for inspection in the completed stage. Therefore, orders may be issued accordingly.

Government Order first cited 3. exempts residential building of 3 dwelling units and less than that and industries from issue of Completion Certificate. Requested revise and make it applicable only for Multi Storeved Building and above 5000 alone. sq.ft. buildings Further, requested to implement the Completion Certificate procedure to other buildings step by step, otherwise public will be put to hardship, as Development Control Regulations stringent. Hence, requested to implement after revision of Development Control Regulations.

It is informed that originally proposal sent was Government vide this office No.19992/2011letter Spl.cell, dated 27.07.2017 requesting to Completion Certificate, applicable to all developments except all ordinary and all industrial buildings. However, Government Order first cited above has been issued covering all category buildings except residential buildings of 3 dwelling units or less than that and industrial buildings under the Completion Certificate, It is procedure. requested consider to exempting all kinds ordinary buildings and kinds of industrial buildings issue of Completion from originally Certificate as proposed by this department vide the above said letter.

The Commissioner of Town and Country Planning has also proposed to collect Rs.1.00/Sq.ft as scrutiny fee to be paid by the applicant and the rates payable to the empanelled professionals may be Rs.0.25/Sq.ft for plinth area inspection and Rs.0.75/Sq.ft in the completed stage.

- 3. The Government have considered the proposal along with remarks of Commissioner of Town and Country Planning in para 2 above. After careful consideration, the Government accept the proposal and direct the Commissioner of Town and Country Planning to collect Rs.1.00/Sq.ft as scrutiny fee to be paid by the applicant and Rs.0.25/Sq.ft payable to the empanelled professionals for plinth area inspection and Rs.0.75/Sq.ft in the completed stage.
- 4. The Commissioner of Town and Country Planning is directed to pursue action accordingly.
